This general induction training covers the mandatory work health and safety training required prior to undertaking construction work or conduct work on a construction site. It includes a basic knowledge of requirements under WHS Act, the common hazards and risks likely to be encountered on construction sites and how these risks should be controlled.

This course is delivered face-to-face in a classroom setting with an assessment conducted via verbal questioning, written testing and practical demonstration.
